ADOPTION OF THE 2013 COUNTY BUDGET  
AND SETTING THE EFFECTIVE DATE  
FOR THE ABOLISHMENT OF SPECIFIC POSITIONS**

WHEREAS, Resolution No. 541 of 2012 adopted the 2013 County Budget; and

WHEREAS, The County Executive vetoed certain items modified and adopted by the Rockland County Legislature in Resolution No. 541 of 2012; and

WHEREAS, By Resolution No. 568 of 2012, the Legislature overrode the County Executive's veto by a majority vote to adopt the 2013 County Budget as modified; and

WHEREAS, The 2013 County Budget will be effective January 1, 2013; and

WHEREAS, The 2013 County Budget includes the abolishment of specific positions to reduce County personnel expenses, said specific positions listed on the annexed Schedule "A"; and

WHEREAS, The County Department of Personnel and other units of County government have advised that due to legal and contractual requirements, the abolishment of said specific positions cannot be effective January 1, 2013 and the effective date must be changed in order to comply with said legal and contractual requirements; and

WHEREAS, The Committee of the Legislature has met, considered and approved this resolution; now therefore be it

RESOLVED, that the effective date of the abolishment of positions listed on the annexed Schedule "A", shall be at the close of business on Friday, February 22, 2013; and be it further

RESOLVED, that Resolution Nos. 541 and 568 of 2012 shall in all respects remain in full force and effect.
