**RESOLUTION NO. OF 2016
CONFIRMING THE APPOINTMENT OF
GILLIAN E. BALLARD, SLOATSBURG, NEW YORK
TO THE ROCKLAND COUNTY ENVIRONMENTAL
MANAGEMENT COUNCIL**

WHEREAS, Chapter 61 of the Laws of Rockland County established the Rockland County Environmental Management Council hereinafter the "Council"; and

WHEREAS, That the Council is necessary to foster unified action on environmental problems among local governments, public and private agencies and organizations located within the County; and

WHEREAS, The Council shall consist of thirteen (13) members appointed by the County Executive subject to Legislative confirmation; and:

WHEREAS, The Council shall also consist of (8) ex officio members and one member from each Commission for Conservation of the Environment that has been established by the governing body of each Town and Village within the County of Rockland; and

WHEREAS, Section C3.02 of the Rockland County Charter authorizes the County Executive to appoint members of Rockland County boards and commissions who shall serve at his pleasure, subject to legislative confirmation; and

WHEREAS, The County Executive has appointed Gillian E. Ballard, Sloatsburg, New York, to a vacancy on the Rockland County Environmental Management Council; and

WHEREAS, Ms. Ballard is interested in the improvement and preservation of environmental quality; and

WHEREAS, There are presently no Commissions for Conservation of the Environment established by any of the Towns or Villages within the County; and

WHEREAS, With the approval of this appointment there will be five (5) vacancies on the Council; and

WHEREAS, The Committee of the Legislature has met, considered and approved this resolution; now therefore be it

RESOLVED, That the Legislature of Rockland County hereby confirms the appointment of Gillian E. Ballard, Sloatsburg, New York, to the Rockland County Environmental Management Council, to serve at the pleasure of the County Executive, and be it further

RESOLVED, That the Clerk to the Legislature is hereby directed to forward a copy of this resolution to the Rockland County Environmental Management Council and to the appointee, Gillian E. Ballard.
