REAPPOINTMENT OF DOROTHY “PENNY” JENNINGS
AND APPOINTMENT OF MARIELLYN DYKSTRA DONNELLAN
TO THE ROCKLAND COMMUNITY COLLEGE BOARD OF TRUSTEES

WHEREAS, by Resolution No. 258 of 2009, the Legislature of Rockland County appointed Dorothy “Penny” Jennings to the Rockland Community College Board of Trustees; and

WHEREAS, the term of Dorothy “Penny” Jennings expired on June 30, 2013, creating a vacancy on the Rockland Community College Board of Trustees; and

WHEREAS, Dorothy “Penny” Jennings has continued to serve as a Rockland Community College Board of Trustees as a hold-over; and

WHEREAS, it is has been recommended that Dorothy “Penny” Jennings of Suffern, New York, be reappointed to remainder of the term, which would expire on June 30, 2018; and

WHEREAS, by Resolution No. 275 of 2010, the Legislature of Rockland County reappointed Caroline Osinga to the Rockland Community College Board of Trustees, to the remainder of a term which term expired on June 30, 2013; and

WHEREAS, the term of Caroline Osinga expired on June 30, 2013, creating a vacancy on the Rockland Community College Board of Trustees; and

WHEREAS, it has been recommended that MariEllyn Dykstra Donnellan of Valley Cottage, New York, be appointed to a five year term, which would expire on June 30, 2018; and

WHEREAS, the _____ Committee of the Legislature has met, considered and approved this resolution, however, it was approved within 120 hours of the full legislative meeting and was deemed an immediate need by its Chair, therefore be it

RESOLVED, that the Legislature of Rockland County hereby reappoints Dorothy "Penny" Jennings to remainder of the term, which term expires on June 30, 2018; and be it further

RESOLVED, that the Legislature of Rockland County hereby appoints MariEllyn Dykstra Donnellan to a five year term, which term expires on June 30, 2018; and be it further

RESOLVED, that the Clerk to the Legislature shall notify the Rockland Community College Board of Trustees and the appointee of this resolution.
