Site plan for a proposed 18,304 sq. ft. retail building, to be tied into an existing 224,846 sq. ft. mixed-use development on a total of 16.76 acres in the LI zoning district and the Route 303 Overlay Zone. Amended site plan for the existing mixed-use development for regrading of an area approximately 20-foot wide along the western boundary of the site; additional notes, updated landscaping plan, and other minor site modifications/additions.

West side of NYS Route 303, south side of Stevens Way, east side of the railroad

NYS Route 303, Palisades Interstate Parkway, Western Highway (CR 15)


The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

***\*Recommend the following modifications***

1. A review must be completed by the Palisades Interstate Park Commission and any raised comments or concerns addressed.
2. A review shall be completed by the New York State Department of Transportation and any required permits obtained.
3. The conditions in the June 26, 2015 letter from the Rockland County Department of Health must be met.
4. There shall be no net increase in the peak rate of discharge from the site at all design points.

**THE SHOPS AT ORANGEBURG COMMONS/ORANGEBURG COMMONS (O-1876W)**

5 Prior to the start of construction or grading, a soil and erosion control plan shall be developed and in place for the entire site that meets the latest edition of the New York State Guidelines for Urban Erosion and Sediment Control.
