### Reason for Referral:

Blaisdell Road (CR 17)

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

### *\*Recommend the following modifications*

- 1 By State Law, the applicant must register with the local fire inspector using Form 209U for the proposed chemical bulk storage materials.
- 2 Under SARA - Title 3, the applicant must register with the Rockland County Fire Training Center.
- 3 A review must be completed by the County of Rockland Department of Highways, any comments or concerns addressed, and required permits obtained.
- 4 A review must be completed by the County of Rockland Department of Health and any required permits obtained.

*In this respect, municipalities are advised that under the Religious Land Use and Institutionalized Persons Act, the preemptive force of any provision of the Act may be avoided (1) by changing a policy or practice that may result in a substantial burden on religious exercise, (2) by retaining a policy or practice and exempting the substantially burdened religious exercise, (3) by providing exemptions from a policy or practice for applications that substantially burden religious exercise, or (4) by any other means that eliminates the substantial burden.*

*Proponents of projects are advised to apply for variances, special permits or exceptions, hardship approval or other relief.*
