**Item:** *YITZCHOK I. & ADEL STERN/20 SUFFERN PLACE (R-2617)*

Variations for lot area, lot width, front setback, front yard, side setback, total side setback, street frontage, maximum development coverage and floor area ratio to allow the construction, maintenance and use of a two-family residence on .2342 acres in an R-15 zoning district.

South side of Suffern Place, approximately 113 feet west of Roberts Road

**Reason for Referral:**

New York State Thruway

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

***\*Disapprove***

The subject site does not meet the minimum lot area standard of 15,000 SF required for a single-family residence. Additional non-conformities include lot width and street frontage. The applicant is proposing to construct a two-family residence with only 51 percent of the required lot area available. The proposed building will require a floor area ratio variance of 100 percent. Additional yard and setback variances are necessary to accommodate an oversized residential building on an undersized parcel. The surrounding neighborhood is characterized by similarly-sized parcels. Granting these bulk variances will set a precedent that may result in nearby property owners seeking the same relief. A doubling of the residential density in this neighborhood of non-conforming parcels will negatively impact its community character. Additional residents will generate more traffic on the local streets. The potential for traffic conflicts is great. While two-family residences are permitted as of right in the R-15 zoning district, they are subject to stricter bulk requirements. This site is particularly deficient in meeting these more stringent standards. We recommend that the required variances be denied.


Permitting development that does not comply with the applicable bulk standards can set an undesirable land use precedent and result in the overutilization of individual sites. As noted above, the lot is significantly undersized and deficient in meeting the lot width and street frontage requirements. The ability of the existing infrastructure to accommodate increased residential density on undersized, non-conforming parcels is a countywide concern and

must be evaluated. This evaluation must consider whether local roads will become more congested and the sewer system, stormwater management systems and the public water supply will be overburdened. The Town must consider the cumulative and regional impacts of permitting such development.

The following comments address our additional concerns about this proposal.

- 1 A review must be completed by the NYS Thruway Authority, and any required permits obtained.
- 2 The NYS Department of State has determined that the Town is not administering or enforcing the State Uniform Fire Prevention and Building Code in accordance with minimum standards set forth in 19 NYCRR part 1203. Given the concerns about the Town's administration and enforcement of the State Uniform Fire Prevention and Building Code raised in the Executive Deputy Secretary of State's letter of July 15, 2016, the proposed residential building must be held to the requisite minimum standards and comply with all requirements of this code.
- 3 A review must be completed by the Rockland County Office of Fire and Emergency Services, the Town of Ramapo Fire Inspector, or the Monsey Fire Department to ensure that there is sufficient maneuverability on site for fire trucks, in the event an emergency arises.
- 4 All proposed building entrances, window wells, walkways and refuse containment areas must be delineated on the site plan demonstrating that they will not impact yard requirements and parking maneuverability for the site.
- 5 It will difficult for vehicles parked in space #2 or #3 to maneuver out of the spaces without a turnaround area. No sidewalks are shown on the site plan, making it difficult to assess the parking area in relation to the pedestrian movement on site, and whether there will be safety issues for the residents. A turnaround area must be provided so that vehicles do not have to back out into the roadway. Walkways must be illustrated on the site plan so that safety issues can be properly evaluated.
- 6 The location of the trash dumpster/refuse container must be illustrated on the site plan. Access to the dumpster must be unimpeded by parked vehicles.
- 7 The site plan shall contain map notes that list all appropriate information, including the district details.
- 8 Pursuant to General Municipal Law (GML) Section 239-m and 239-n, if any of the conditions of this GML review are overridden by the board, then the local land use board must file a report with the County Commissioner of Planning of the final action taken. If the final action is contrary to the recommendation of the Commissioner, the local land use board must state the reasons for such action.
- 9 In addition, pursuant to Executive Order 01-2017 signed by County Executive Day on May 22, 2017, County departments are prohibited from issuing a County permit, license, or approval until the report is filed with the County Commissioner of Planning. The applicant must provide to any County agency which has jurisdiction of the project: 1) a copy of the Commissioner report approving the proposed action; or 2) a copy of the Commissioner of Planning recommendations to modify or disapprove the proposed action, and a certified copy of the land use board statement overriding the recommendations to modify or disapprove, and the stated reasons for the land use board's override.
