Item: *CONGREGATION BETH DAVID/48-50 MOUNTAIN AVE (R-1300D)*

Variances for front setback (Mountain Avenue) and front yard (Mountain Avenue) to permit the continued use of a school of religious instruction on 1.72 gross acres (1.70 net acres) in a R-25 zoning district. A side setback variance is also required for a proposed addition to the caretaker's residence.

Northeast corner of College Road and Mountain Avenue.

Reason for Referral:

College Road (CR 81), Highview Avenue (CR 64)

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

****Recommend the following modifications***

- 1 An updated review of the June 11, 2018 revised planimetric plan must be completed by the Rockland County Highway Department, and all required permits obtained. In addition, the applicant must comply with all conditions of the Highway Department's letter of January 30, 2018.
- 2 An updated review of the June 11, 2018 revised planimetric plan must be completed by the Rockland County Health Department, and all required permits obtained. In addition, the applicant must comply with all conditions of the Health Department's letter of January 31, 2018.
- 3 An updated review of the June 11, 2018 revised planimetric plan must be completed by the Rockland County Sewer District #1, and all required permits obtained. In addition, the applicant must comply with all conditions of the Sewer District's letter of February 1, 2018.

- 4 The NYS Department of State has determined that the Town is not administering or enforcing the State Uniform Fire Prevention and Building Code in accordance with minimum standards set forth in 19 NYCRR part 1203. Given the concerns about the Town's administration and enforcement of the State Uniform Fire Prevention and Building Code raised in the Executive Deputy Secretary of State's letter of July 15, 2016, the school building and the caretaker's residence must be held to the requisite minimum standards and comply with all requirements of this code
- 5 A review must be completed by the Rockland County Office of Fire and Emergency Services, the Town of Ramapo Fire Inspector, or the Monsey Fire Department to ensure that there is sufficient maneuverability on site for fire trucks, in the event an emergency arises.
- 6 Permitting development that does not comply with the applicable bulk standards can set an undesirable land use precedent and result in the overutilization of individual sites. A 125 percent increase over the maximum development coverage was previously permitted, as well as several yard and setback variances. The ability of the existing infrastructure to accommodate large educational facilities on undersized parcels is a countywide concern and must be evaluated. This evaluation must consider whether local roads will become more congested and the sewer system, stormwater management systems and the public water supply will be overburdened. The Town must consider the cumulative and regional impacts of permitting such development.
- 7 A turn-around area must be provided at the northern end of the parking lot. The dumpster enclosure will have to be moved further north to achieve this.
- 8 Map Note 10 must specify that "SUEZ" is the water supplier, not "United Water." Map Note 15 must list the variances granted.
- 9 Pursuant to General Municipal Law (GML) Section 239-m and 239-n, if any of the conditions of this GML review are overridden by the board, then the local land use board must file a report with the County Commissioner of Planning of the final action taken. If the final action is contrary to the recommendation of the Commissioner, the local land use board must state the reasons for such action
- 10 In addition, pursuant to Executive Order 01-2017 signed by County Executive Day on May 22, 2017, County departments are prohibited from issuing a County permit, license, or approval until the report is filed with the County Commissioner of Planning. The applicant must provide to any County agency which has jurisdiction of the project: 1) a copy of the Commissioner report approving the proposed action; or 2) a copy of the Commissioner of Planning recommendations to modify or disapprove the proposed action, and a certified copy of the land use board statement overriding the recommendations to modify or disapprove, and the stated reasons for the land use board's override

**NYS General Municipal Law Section 239 requires a vote of a 'majority plus one' of your agency to act contrary to the above findings.*

The review undertaken by the Rockland County Planning Department is pursuant to, and follows the mandates of Article 12-B of the New York General Municipal Law. Under Article 12-B the County of Rockland does not render opinions, nor does it make determinations, whether the item reviewed implicates the Religious Land Use and Institutionalized Persons Act. The Rockland County Planning Department defers to the municipality forwarding the item reviewed to render such opinions and make such determinations if appropriate under the circumstances.

In this respect, municipalities are advised that under the Religious Land Use and Institutionalized Persons Act, the preemptive force of any provision of the Act may be avoided (1) by changing a policy or practice that may result in a substantial burden on religious exercise, (2) by retaining a policy or practice and exempting the substantially burdened religious exercise, (3) by providing exemptions from a policy or practice for applications that substantially burden religious exercise, or (4) by any other means that eliminates the substantial burden.

Proponents of projects are advised to apply for variances, special permits or exceptions, hardship approval or other relief.

Pursuant to New York State General Municipal Law §239-m(6), the referring body shall file a report of final action it has taken with the Rockland County Department of Planning within thirty (30) days after final action. A referring body which acts contrary to a recommendation of modification or disapproval of a proposed action shall set forth the reasons for the contrary action in such report.
