
The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

***\*Recommend the following modifications***

- 1 A review must be done by the Rockland County Department of Health to ensure compliance with the Rockland County Sanitary Code, Article XIX, Mosquito Control.
- 2 Prior to the start of construction or grading, a soil and erosion control plan shall be developed and in place for the entire site that meets the latest edition of the New York State Guidelines for Urban Erosion and Sediment Control.
- 3 There shall be no net increase in the peak rate of discharge from the site at all design points.

**RIVER RIDGE ESTATES - LOT #4 (SN-34Y)**

4 Portions of the proposed retaining wall are up to 10 feet in height. To break up these massive walls, the walls should not exceed four (4) feet in height from the finished grade and be stepped or terraced. The width of the terraced area between any two (2) four-foot or less vertical retaining walls shall be at least five (5) feet. Terraces between retaining walls shall be permanently landscaped or re-vegetated. These retaining walls shall be screened by vegetation or faced with wood, stone or other earth colored materials that blend with the surrounding natural landscape.
