**Item:** *WEST HAVERSTRAW, LLC (WH-168C)*

Site plan for the proposed demolition of an existing meeting hall, and construction of a parking lot for accessory vehicle storage on two parcels that total .9 acres, and are currently in the R-3 zoning district, for an existing adjoining car dealership. A zone change application has been submitted to rezone the two parcels to the C zoning district.

West side of Cosgrove Avenue, approximately 20 feet north of Center Street

**Reason for Referral:**

US Route 9W, Helen Hayes Hospital

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

***\*Recommend the following modifications***

- 1 A review shall be completed by the New York State Department of Transportation (NYS DOT) and all required permits obtained. The concerns raised in the NYS DOT August 28, 2014 letter for the proposed zone change and text amendment regarding the potential of the site being used as a cut-through and any potential increase in traffic entering and exiting the current driveways on Route 9W must be addressed.
- 2 The lighting plan must show fields of illumination and the proposed on-site lighting sources shall not extend beyond the property line.
- 3 There shall be no net increase in the peak rate of discharge from the site at all design points.
- 4 A review must be done by the Rockland County Department of Health to ensure compliance with the Rockland County Sanitary Code, Article XIX, Mosquito Control.
