**Item:** *ROCKLAND BAPTIST CHURCH (WH-183)*

A site plan application to convert an existing commercial building into a house of worship on 0.46 acres in the C zoning district.

The eastern side of Samsondale Avenue, approximately 275 feet south of East Railroad Avenue.

**Reason for Referral:**

East Railroad Avenue (CR 94)

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

***\*Recommend the following modifications***

- 1 A review must be completed by the County of Rockland Department of Highways and any required permits obtained from them.
- 2 A review must be completed by the County of Rockland Department of Health and any required permits obtained from them.
- 3 All proposed signage shall be indicated on the site plan and shall conform to the municipality's sign standards.
- 4 The site plan shall contain map notes, including district information.
- 5 Two parking spaces (the northwesternmost and southeasternmost spaces at the end of each row) do not have adequate back up space due to the encroachment of property lines and fencing. They must not be counted toward the required parking.

6 To reduce the extent of the maximum development coverage variance, pervious pavers must be used.

*The review undertaken by the Rockland County Planning Department is pursuant to, and follows the mandates of Article 12-B of the New York General Municipal Law. Under Article 12-B the County of Rockland does not render opinions, nor does it make determinations, whether the item reviewed implicates the Religious Land Use and Institutionalized Persons Act. The Rockland County Planning Department defers to the municipality forwarding the item reviewed to render such opinions and make such determinations if appropriate under the circumstances.*

*In this respect, municipalities are advised that under the Religious Land Use and Institutionalized Persons Act, the preemptive force of any provision of the Act may be avoided (1) by changing a policy or practice that may result in a substantial burden on religious exercise, (2) by retaining a policy or practice and exempting the substantially burdened religious exercise, (3) by providing exemptions from a policy or practice for applications that substantially burden religious exercise, or (4) by any other means that eliminates the substantial burden.*

*Proponents of projects are advised to apply for variances, special permits or exceptions, hardship approval or other relief.*

*Pursuant to New York State General Municipal Law §239-m(6), the referring body shall file a report of final action it has taken with the Rockland County Department of Planning within thirty (30) days after final action. A referring body which acts contrary to a recommendation of modification or disapproval of a proposed action shall set forth the reasons for the contrary action in such report.*
